The TED worldwide award is one of the world's biggest teddy bear contest. Hosted by the leading German teddy bear magazine **BärReport**, it is a truly international competition: with participants from all five continents, an independent jury from different countries and last but not least many thousands of bear loving voters from about 50 countries around the world.

As organizers we take pride in our innovative system of entry categories which are far more flexible than any other major competition you may know. To make the TED worldwide more interesting and exciting for hobbyists and artists we have already introduced the „Masterclass“. The Masterclass ensures that there will be a continual change in the artist class: All artists who have been nominated two times in this class (i.e. in two TED worldwide competition years) have to enrol in the Masterclass. Manufacturers only have the possibility to take part in the Masterclass with a creation of an artist working for them. With these rules we want to encourage bear makers – hobbyists and artists likewise – to enhance their artistry in making teddy bears and to be more creative than ever.

The juries in the past consisted of such renowned teddy bear authorities like: Natalia Demchenko (Russia), Pat Rush (Great Britain), Yau-Zeng Lin (Taiwan), Günther Hofer (Germany), Peter and Leanda Woodcock (Great Britain), Verena Green-Christ (Germany), Nelleke van den Berg (Netherlands) and Laura Sinanovitch (Switzerland). They guarantee a fair and careful preselection of all entries. To prevent arrangements among the members of the jury they get to know the identity of the other members not before the rating is completed.

The readers of the **BärReport** magazine and - via the website [www.baerreport.de](http://www.baerreport.de) - teddy enthusiasts from all over the world then make the final decision.

Joining a competition is a wonderful way to promote your work. We want to support this idea and therefore all nominated entries will be presented on the **BärReport** website as soon as the **BärReport** issue 4/2009 is published (December 2009), furnished with the names of the nominees. All nominated entries are shown to the public in a special exhibition at the prestigious Teddybär Welt fair in Wiesbaden.

## Contest Rules

Thanks to its innovative category system the TED worldwide contest is perfectly suitable for the inventive and expressive designs of the 21st century. Please choose your appropriate class:

### I HOBBYIST

Hobby teddy bear makers who have been making bears for less than three years and who do not sell their bears on a regular basis. Applicants who have taken part two times as hobbyist can not compete again as hobbyist and have to enrol in the another class.

### II ARTIST

Teddy bear artists who have been making bears for at least three years or who sell their bears on a regular basis.

### III MASTERCLASS

Teddy bear artists who have been nominated in the artist class two times (in two different TED competition years) have to enrol in the Masterclass. Manufacturers can only take part with the creation of an artist working for them.

To do justice to the many ideas of today we have selected the fol-

lowing categories:

#### A) MINIATURE TEDDY, UNDRESSED

Up to 5", artist bears or teddy bears in their original form, material selection is at your choice.

#### B) MINIATURE TEDDY, DRESSED

Up to 5", artist bears or teddy bears in their original form, material selection is at your choice.

#### C) OLD FASHION TEDDY BEAR

Up to 20", undressed, you are asked to present the original old fashion form of the teddy bear (up to the fifties). Material and filling must adjust to the traditional style.

#### D) DESIGN VARIATION, UNDRESSED

Up to 20", artist teddy bears, material selection is at your choice.

#### E) DESIGN VARIATION, DRESSED

Up to 20", artist teddy bears, material selection is at your choice.

#### F) MIXED MATERIALS, UNDRESSED

Up to 20", any choice of material and material-mix is asked for in this category. Your original ideas are given plenty of space to create something unique.

#### G) MIXED MATERIALS, DRESSED

Up to 20", any choice of material and material-mix is asked for in this category. Your original ideas are given plenty of space to create something unique.

#### H) NATURE BEAR

Height of shoulder up to 16", natural bears like polar bear, grizzly bear or suchlike are asked for in this category.

#### I) THE ZOO

Up to 20", show your creativity! Any type of animal or fantasy design can be submitted in this category. Theme groups like fairy-tale characters, animal families or a dragon with his rider will be accepted as well.

#### J) PURELY MECHANICS

Up to 20", teddy bears or animals, creatures on all fours or standing designs: all these creations have to include mechanical parts. Whether it includes wheels or a music box, a bear with moving head or arms or similar things - mechanical items are a must.

#### K) SUBJECT: BEAR

You have not found a competition category for your designs yet? How does a jeweler, a fashion designer, a painter or maker of accessories realize his or her ideas? This is the right category for you.

## How to find the right category for your entry:

A teddy bear is "undressed" when he is only wearing a bow, a collar or possibly a muzzle. The bears in the "undressed" categories must not have any additional accessory. Otherwise they will be regarded as „dressed“.

A "dressed" teddy bear may carry a small accessory if it distinctly displays the character or profession of the bear. Accessories must be fastened securely to the bear or the clothing. Props are not allowed.

No scenic presentations are permitted. Therewith a decorative scenery is meant with objects which do not actually belong to the bear, animal or fantasy creation (so called props). **Please note that any violation of this rule will result in the disqualification of the entry.**

"Mixed materials" is a category which fosters any type of unusual mix. For example: mohair body and sculptured or wooden face.

The category "The Zoo" is open for all applications like animals or fantasy creations.

"Purely mechanics" includes all types of mechanics for and with bears and animals, decorated musical boxes or body mechanics of any kind. It could be a bear on all fours fastened on wheels as well as an animal with a moving body.

"Subject: bear" presents the world of design. This is the right category for your jewelry, clothing, paintings/drawings or even small furniture as long as the bear remains its main subject.

In the categories A-H and J besides single bears pairs are allowed if they represent a theme. Examples: Anne & Andy, brother & si-

ster, mother & child, Jack & Jill. The restriction of a maximum of two bears is not eligible to the category I (The zoo). Here as well presentations of groups call for a theme.

**BärReport** reserves its right to oversee the placement of an entry into a certain category and to correct it if necessary.

At least six entries have to take part in one category otherwise this category will be closed for this year's competition because we want to guarantee that there is a real competition.

At least two participants have to be nominated per category otherwise this category will be closed for this year's competition.

If there will be not enough nominees in the categories concerning the miniature teddies a superior category for the miniature teddies will be created.

It is not allowed that the submitted objects take part in other competitions or are presented at shows or in teddy bear magazines before 15th November 2009.

## Application

Please use our official application form. In order to judge your work correctly we request you to send three professional photos (high gloss, c. 4" x 6") which show front and side view (or back view if necessary) and also a close-up of the head. For category J (Purely mechanics) two more pictures or sketches which show the mechanics (possibly before installation) are required. Please attach an adhesive label or sticker with your name and the name of the entry on the back side of each picture. Remember that these photos will promote your work. Please leave the "teddy on a sofa" at home.

The pictures that are submitted to the competition and the pictures of the competition objects that are taken by the organizer himself during the Teddybär Welt show are the belongings of the organizer. They can be published in the **BärReport** magazine or in any other publication of the organizer without any approval of the participants of the competition and exempt from charges.

The admission fee for the first entry is EUR 32,00. Any further application fees are EUR 22,00 each. For hobbyists (according to our definition) the admission fee for the first entry is EUR 27,00. Any further application fees for hobbyists are EUR 17,00 each. The relevant date for being a hobbyist or not is the deadline of this contest. BärReport reserves his right to check the details. The admission fee is payable when you are submitting the application form.

It is only possible to pay by bank transfer or in cash. Cheques and credit cards will not be accepted.

## The STEIFF special award!

**F**or the third time the STEIFF special award is assigned in the course of the TED worldwide 2010: the Margarete Steiff GmbH offers the three first laureates the possibility of incorporating their objects to the STEIFF assortment program. A four-headed jury of the Margarete Steiff GmbH acquires the winners of the STEIFF special award. The first placing is endowed with 3000 €, the second placing with 1500 € and the third placing with 500 €. If one of these objects will get into serial production and marketing, the winner receives a participation of 3 % in the STEIFF net turnover for this product for the first year after the market launch.

All nominated objects of the TED worldwide competition are approved for the STEIFF special award. Please pay attention to the acceptance of the participation to the STEIFF special award competition in the registration form: „If my submission is nominated for the TED worldwide 2010, I would like to participate in the competition of the STEIFF special award. The jury forms can be picked up at the Teddybär Welt during Sunday, 14th March 2010. Otherwise we are going to send them to the participants with standard mail.
